

GOVERNMENT ADVOCACY TEAM ADOPT A LEGISLATOR CAMPAIGN

July 3 to August 5

The Government Advocacy Team's purpose is to engage, elevate and serve the PIHRA community. The Team monitors and evaluates current employment laws, pending legislation, and regulations at the federal, state, and local level that may have an impact on human resources management throughout the state.



Team Instructions

Our California representatives are on recess this month. In July we launch of our Government Advocacy Team's Adopt a Legislator program. This is an opportunity for our Chapter GAT Legislative Chairs and the Advisory Committee to reach out to the state representatives in our home districts (where we live) and schedule a "get to know us" session with our local representatives. We will be informing our representatives of our mission while getting to know them at the same time. We have plenty to discuss including PAGA and Veteran's Preference.

The following will provide you with a step-by-step process for contacting your legislator:

1. Constituents are always priority!

During the legislature's recess it is an excellent time to visit local district offices. First, verify that your legislators will be in their home district. During the year, legislators are in their district offices late Thursday afternoons and all-day Friday.

- o Locate both your state assembly members and senators in the district that you live and vote in.
- Find your state representatives: https://findyourrep.legislature.ca.gov/



2. Schedule a meeting.

- Call the legislator's district or capitol office, ask for the district scheduler. Often, you'll be given an email address, and you can send a quick introductory email.
- o Be sure to get the scheduler's full name, if possible.
- 3. Our goal is to get to know the legislators or their staff.
 - Always meet with the representatives or staff in person whenever possible. Virtual meetings are fine, but not as much fun. Staff are a very valuable resource, and often are around after a legislator terms out.
 - o Learn, record and use the names of the office staff.
- **4.** Set up a meeting with your legislator and / or their staff:
 - Your meeting will generally last only about 15-20 minutes, so you'll need to get straight to the point.
 - o Don't be upset if you meet with a staffer and not the representative. Their support is invaluable.
 - Be your legislator's local employment, labor or benefits expert. You are their PIHRA/CalSHRM representative and HR expert.
 - Be prepared. Explain PIHRA's role, its membership, and our current legislative issues. See attached Fact Sheet.
 - Leave behind the attached Fact Sheet, your business card, and any other requested GAT approved materials for their reference. Keep material brief and to-the-point.
 - Always thank the legislators for their time with a handwritten card. If you are pressed for time, an email note is fine.
 - Share with us your experience, we want to hear about it! Email Dana Mayhew at advocacy@pihra.org.
 - Keep in touch. Contact your legislator and staff several times per year on a regular basis.
